Community Action Head Start is a comprehensive early childhood education program for children age birth to five years who face barriers to success. Baseline eligibility is a family income at or below 100% of the federal poverty level (\$31,200/year for a family of four).

From early math and reading skills to confidence and resilience, we help children **build skills for success in school and life.** Our whole-family approach empowers families to **break the cycle of poverty.**

We also promote development of healthy behaviors, such as regular fruit and vegetable consumption and physical activity, through evidence-based interventions.

Highlights


In 2024, construction ended at the **Bansal Family Home for Head Start** at 1821 K Street in Lincoln, the result of a successful \$3.5 million capital campaign. The space has been transformed into one designed specifically for young children and their families.

Community Action Head Start's Onthe-Job Training program continues to offer qualifying employees the opportunity to receive supports while pursuing educational goals and career advancement. To date, **over 70** teachers have participated in this program.

Financial Audit Results

Community Action Partnership of Lancaster and Saunders Counties' consolidated financial statements were audited by independent auditors in January 2024. Due to annual expenditures of greater than \$750,000 in federal funding, the audit was conducted in compliance with the requirements of U.S. Office of Management and Budget 2 CFR 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards. In Community Action's fiscal year-end September 30, 2023 audit report, the auditors expressed unmodified opinions on the consolidated financial statements of Community Action and affiliates. During the audit, no instances of noncompliance material to the consolidated financial statements were disclosed. There were no audit findings relative to the major federal award programs for Community Action. In the report, the auditors determined Community Action is a low-risk auditee.

In the Independent Auditor's Report on Internal Control Over Financial Reporting on Compliance and Other Matters, the auditors found no material weaknesses and one significant deficiency relating to the audit of the consolidated financial statements. The finding related to non-federal revenue recognition and expense accrual. The agency has since implemented a corrective action plan to ensure that all financial statement line items are properly stated. A copy of the results is available at: facdissem.census.gov.
